

Abts was one of the first writing about the need to have a "Living Trust" and discussions about the

time frame and the costs of passing on with out having a Trust cover the appendix of this book. Not the most current, but good for the "basics" needed to carry on a discussion about planning for a Trust. Henry did not like attorneys! If you can get past that there is a lot of information to be gleaned from this book. I like the appendix sections the best, but the whole book is good, but a little slow in the front...

The Living Trust is in the third edition printing...if the Congress decides what it is going to do for the country a Fourth Edition of this planning guide would/could be well along!Henry Abts does not like attorney's and his illustrations show why he does not. The Book is a good read on a subject that more people could take advantage of to save money by avoiding probate. The description of probate, and the costs associated with taking an estate through probate are enough to encourage anyone with a choice to AVOID Probate!The appendix section is a good read by itself with a question/answer format.As soon as an update is published, I will buy that...but I don't know the schedule!

A living trust must be written by a lawyer. However, if you don't know what questions to ask or what information should be included, especially splitting of assets, most lawyers will not volunteer any helpful information. The resulting trust may not work the way you planned. Once one of the original settlors dies, their portion becomes part of a bypass trust that can't be changed. The survivor must live with whatever is defined in the bypass trust. At the time of death of the first settlor, all assets are divided between at least two trusts: the survivor's trust and the bypass trust. If the original trust is not written carefully and thoughtfully, making corrections are costly and may be impossible. This book, The Living Trust by Henry Apts III, is a revised edition published in 2003, the last update before Mr. Apts passing. An important companion book is Henry Apts "How To Settle Your Living" Trust", published in 1999. Henry Apts started a company "The Estate Plan" which he franchised to various independent estate planners. Some controversy has surrounded some of these independent planners using The Estate Plan but this should not be construed as judgement against the Living Trust books. I have used these books for the last thirteen years as trustee to two living trusts and have found the information to be fairly accurate and a good basis to begin detail research from. Definitely don't ever, ever rely solely on a lawyer to develop your trust. I am a survivor of a irrevocable trust written by a prominent trust lawyer, since retired, now trying to sort out problems he created. Three lawyers later, I believe I have found a competent lawyer who truly understands trusts even though I have had to have him correct some of his own documents - keep in mind that I'm not

a lawyer, just a layman who learns by trial and error.

Good informative book but the tax information is badly out of date

This is THE book on "Living Trusts". When I compare what they do with regular attorneys, they leave the attorneys in the dust. They happen to cost about a quarter of what a regular attorney charges, and do twice the work. Highly Recommended. If you have a trust put together by someone else, read the book and they have them evaluate your trust. What they find (or don't find) will amaze you. By they way, they're in Reno, but they have representatives everywhere.
