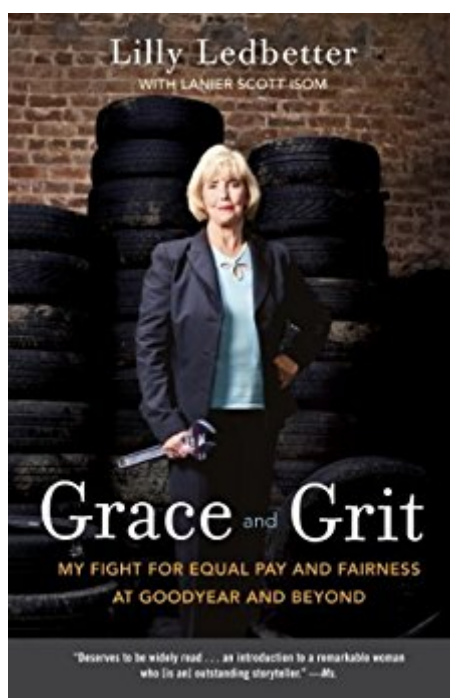

# Grace And Grit: My Fight For Equal Pay And Fairness At Goodyear And Beyond



## Synopsis

The inspiring story of the woman at the center of the historic discrimination case that inspired the Lilly Ledbetter Fair Pay Restoration Act, her fight for equal rights in the workplace, and how her determination became a victory for the nation. Lilly Ledbetter always knew that she was destined for something more than what she was born into: a house with no running water or electricity in the small town of Possum Trot, Alabama. In 1979, when Lilly applied for her dream job at the Goodyear tire factory, she got the job. She was one of the first women hired at the management level. Nineteen years after her first day at Goodyear, Lilly received an anonymous note revealing that she was making thousands less per year than the men in her position. When she filed a sex-discrimination case against Goodyear, Lilly won--and then heartbreakingly lost on appeal. Over the next eight years, her case made it all the way to the Supreme Court, where she lost again. But Lilly continued to fight, becoming the namesake of President Barack Obama's first official piece of legislation. Both a deeply inspiring memoir and a powerful call to arms, *Grace and Grit* is the story of a true American icon.

So good to know that there are women like her. Thank goodness too for her dedicated lawyer and shame on the organizations and people who are so abusive and tolerant of injustice toward workers.

I read this memoir rapidly and with righteous anger and sympathy. Goodyear will never get my business! The treatment of Lilly Ledbetter destroyed her physical health and deprived her and her family of fair remuneration for her herculean efforts to perform her job. I hope many men and women learn from this book and understand better why protections and equal rights legislation are so important.

I chose to read this book because the topic of Fair Pay for women interested me and I was familiar with the Lilly Ledbetter case. Her courage and persistence impressed me. It is individuals like her who advance worthy causes -- often at great cost to themselves. Her intelligence and obvious abilities helped her advance, but she was treated very unfairly. This book shows the difficulties encountered by women as they battle the world in many ways. Most especially there is great insight into feminine travails in the work place. Mrs. Ledbetter is to be admired for her fight for women to obtain equal pay for equal work when men and women do the exact same things.
