

The book follows a logical and well organized road, beginning with preparing the reader for understanding the complex interplay of parents, schools, disabilities, and the Individuals with Disabilities Education Act and other disability laws. Among the important lessons that authors Pamela and Peter Wright teach are how to organize your files using a document management system, how to use private sector expert evaluations of your child and why they are essential, and how to understand the critical role of testing, percentile ranks, and the Bell Curve, and how to use those results to work for your child's "SMART IEP". The use of the "Columbo Strategy" to build valid IEP goals by asking "who,

There is a lot of things in this book that really resonated with me and helped me become both a better advocate. One was the approach to organizing and reviewing materials in order to be better prepared for IEP and IEE meetings. Another was the evaluation of testing data to determine whether real progress was being made. In that case, I learned a lot about the tests in general and

where gaps may have occurred in my child's education. The section on negotiation strategies also proved helpful to me and I'm sure the letter writing section will be something I will need at some point. This book is full of homework for you, so you don't sit down and read it cover to cover. But, if you do the work, you are going to be a much better advocate. The legal experience of the Wrights is invaluable, and they are sharing it with us for a very reasonable amount. While I didn't need many sections of the book, I'm certain there are others out there who do and I hope they are as helpful as the ones I've completed.

This book has been so helpful in preparing me for transitioning my daughter into preschool. It is very accessible and so easy to understand - you don't need to be a scholar or a lawyer to understand your child's special education rights! A lot of the information pertains to older school age children, obtaining evaluations and using existing test scores to help you down the path of special education, but i still found a lot within these pages that applies to my toddler who is transitioning out of state-provided autism therapy and into a public preschool. Another nice feature is the 'homework assignments' and how-to information on organizing your child's files, understanding test scores and statistics, and creating a master plan for your child's education. It's homework that you'll want to do!

This book was a tremendous help to me while preparing for my daughter's IEP meeting. Using information and templates in the book was very helpful in helping me to advocate for my daughter and obtain resources from the school system that I have been trying to get for years. I highly recommend this book to anyone advocating for a child to receive services pursuant to IDEA. It is written in a manner that is easy to read and understand.

I purchased the e-book because I needed the book fast before a meeting with the school. I like that it was available in both formats. This book is a MUST READ for any parent of a child with a suspected disability. It is written in a clear and easy to understand style. It gives you the information you need to understand the process of determining eligibility for special education services and/or a 504 plan for modifications. It gives good tips on getting yourself organized and how to deal with other parties such as the school administrators. It explains what an IEP is and what an IEP should include. It explains basic statistics and how results can be looked at in several different ways. Before this book I had no clue what my rights as a parent were. I did not know where to go to get that information, either. This book tells you. It is empowering. If you are debating whether or not it is worth it...buy it. Don't hesitate. Buy it now. Seriously.
