

This book is a gem. As a law student, I took Corporations having zero knowledge of finance and accounting (by "zero" I mean "negative ten"); I didn't even know what "stock" was. This book has

been a comprehensive and comprehensible step-by-step approach to understanding the intricacies of corporate structure and finance. It explains legalese and business concepts concisely and the statutory or case law from which they came (this is crucial for the study of law, as lawyers rely heavily on precedent, i.e., the answer to "where did this come from?"). As a student, I have read through many so-called hornbooks and treatises that summarize particular areas of law, and this one is hands-down among the top, especially in light of the dense material it covers. The book is idiot-proof and almost impossible not to understand, as, among other things, it is neatly divided into sections that follow a logical progression. If, like me, you have struggled to figure out where certain concepts fit into the bigger picture and online term-by-term searches have yielded no more than a patchy understanding of something you still won't quite get, you will love this book. You will see exactly how and where such isolated concepts fit in the complex world of corporations law.
