

He joined the faculty at Bentley in 1996 and has remained there. At Bentley, he serves as the coordinator for all audit and assurance curriculum matters. His off-campus commitments include

consulting with the Audit Learning and Development group at KPMG.Professor Thibodeauââ ¬â,¢s scholarship focuses on audit judgment and decision making and audit education. He is a coauthor of two textbooks and has written more than 40 book chapters and articles for academics and practitioners in journals such as Auditing: A Journal of Practice & Theory, Accounting Horizons, and Issues in Accounting Education.Professor Thibodeau served as the President of the Auditing Section of the American Accounting Association for the 2014/2015 academic year.
