

Why? Well, when you teach law it is always useful to have both the historic context and the general dates of when decisions are made. The team bring in a focus on the people involved and consequences which, as any student of tort will know, makes that human element all the more enriching as we are dealing with real people such as those we cross examine in court which is probably the most interesting and exhilarating part of any trial.
