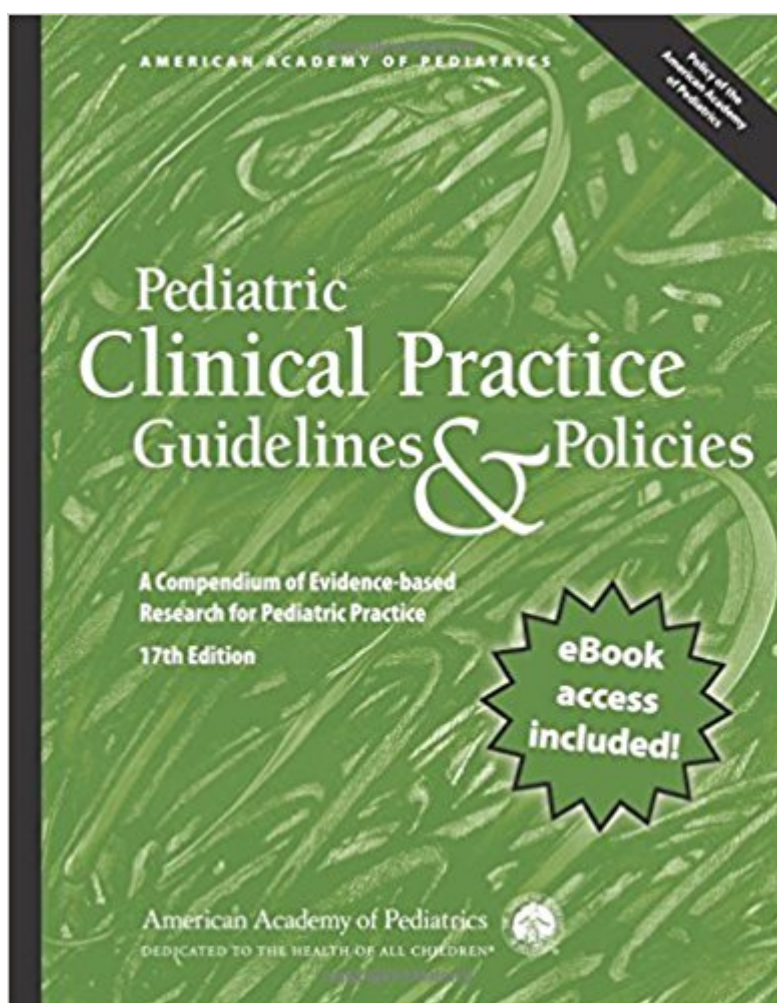

The AAP is the largest pediatric publisher in the world, with a diverse list of resources that includes essential clinical and practice management titles and award-winning books for parents.

As a pediatrician, I was really excited at the prospect of having a book with all the endorsed pediatric guidelines inside. However, not all of the guidelines are in this book. The only guidelines in the book are the ones that are from the AAP itself that are contained in the first section of the book:

11 guidelines in total including topics like ADHD, BRUE (aka ALTE), Bronchiolitis, AOM, and UTI. Any guideline that is ENDORSED by the AAP, but written by another medical organization (Infectious disease society, American College of Emergency Physicians, etc) only has a brief abstract. Essentially, there are 33 endorsed guidelines that are referenced in the book and the actual details are not in the book itself. The rest of the book is dedicated to policy statements that are useful in an outpatient setting for parental education on almost every topic you can think of. BOTTOM LINE: Great for Pediatric Policies and disappointed with respect to clinical guidelines as 75% of them are MISSING from the book.
