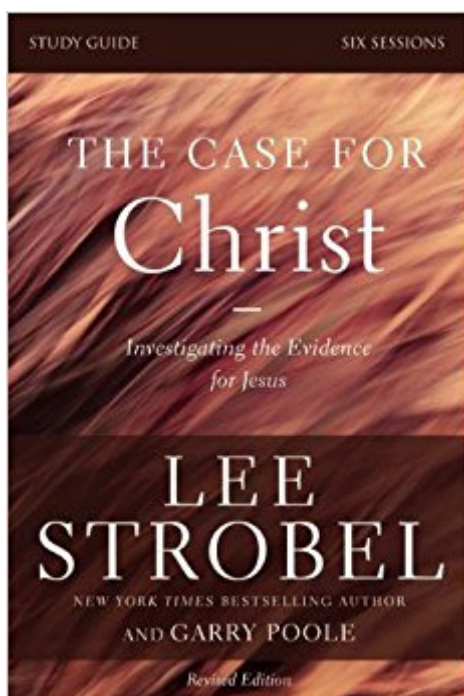

A lot of provocative questions are included. My Sunday school class found, however, that many of the questions had obvious answers to them because they are all firm believers in Jesus Christ.
