

This book updates and expands on his four previous books, which established a comprehensive framework for understanding the many ways that local land use authority can be used to preserve natural resources and environmental functions at the community level. Standing Ground describes in detail how localities are responding to new challenges, including the imperative that they adapt to and help mitigate climate change and create sustainable neighborhoods. This body of work emphasizes the critical importance of law in protecting the environment and promoting sustainable development. Standing Ground looks at the legal foundations of local environmental law within the federal legal system, how traditional land use techniques can be used to protect the environment, and innovative and flexible methods for protecting fragile environmental areas and for making urban neighborhoods livable. Nolon examines the effects of climate change on sea level and storm surges, examining local strategies for disaster preparation, mitigation, and recovery. He discusses the growing emphasis on green infrastructure and urban agriculture as crucial strategies for fostering a healthy environment and analyzes the role of environmental impact review. The book concludes with a discussion of environmental dispute resolution and consensus-based land use decision-making. I heard this author speak today at the American Planning Association meeting in Norman at OU. The stories of the east coast legal battles were interesting but Nolan's talk became fascinating when he explained the best local ordinance in the country was none other than Oklahoma City's. (Santa Fe came in at a close 2nd). It was written in the 1980s before the big drilling companies could "help" wordsmith it.Nolan's premise was not about a strategy to ban hydrofracking but about how local people could REGULATE the drilling methods so as to ensure the safety of the public from air pollution, water contamination, and soil damage. His talk was so educational I felt like I should have written him a \$200 check for the consultation! I think this book will make a huge contribution to communities wanting to be smart about how to protect themselves against unintended consequences. Nolan stressed using collaborative approaches.
