

Fred C. Lunenburg is Professor and Senior Research Fellow in the Center for Research and Doctoral Studies in Educational Leadership at Sam Houston University. Prior to moving to university teaching, he served as a high school principal and superintendent of schools in Minnesota and Wisconsin. He has authored or co-authored 18 books, including THE PRINCIPALSHIP (with Beverly Irby), published by Wadsworth Cengage Learning. Allan Ornstein (Ph.D., New York University) is Professor of Education at St. John's University in New York. He is the author of more than 55 texts and 400 articles and research papers, and has served as a consultant for more than 60 government and educational agencies. He is a co-author of FOUNDATIONS OF EDUCATION, now in its twelfth edition (Wadsworth Cengage Learning).

This book has some great practices for administrators, but finding information within it is difficult. The glossary does not have any common terms and navigating the table of contents is tedious at times, especially when half of it is missing! did take care of the missing table of contents, but the book overall could be better.

This book has great info on the progression of education - although the chapters are loaded with information. It could be organized a little better without so much info to sort through each chapter.

The print book is made stronger by the diverse figures, tables and images it borrows from other authors and thinkers. I am finding to my dismay that many of the PIVOTAL figures and charts are NOT included in the Kindle edition. The publisher was not willing to pay copyright and licensing fees required to include the figures in the digital version as well as the print. The missing figures phenomenon doesn't happen just once or twice -- it is frequent and distributed. I am having to go back and pay for the print version as well, just to have the full textbook when the professor calls our attention to, and discusses, specific visual information he assumes we all have.

Whereas I'm an Ornstein fan, I expected to like this book. It covers the main subjects of education administration while providing a lifetime's worth of references for further reading and research. In some ways, this book is a summary of the growing body of literature up to the point when it was published.

Quite dry. Even for a textbook. Nonetheless, it is full of appropriate information concerning educational leadership and loaded with research. In my course that 'used' this textbook the professor seemed to deliberately avoid the textbook in favor of more dynamic articles.

This is an exceptionally well written book that all administrators should have on hand for reference.

The moral development of school leadership is great. Very concise book filled with many administration theories. Was able to keep up with class using newer version. Used the editor's online book preview for parts not in the older version.

As a graduate textbook, it has value, but I would like more detail in some of the legal sections.
