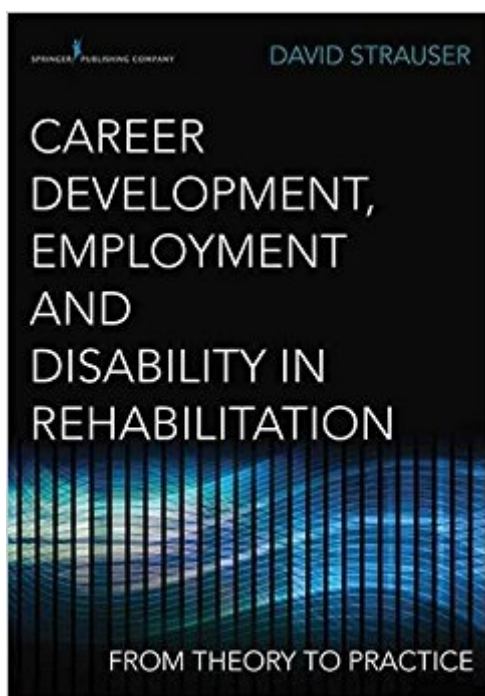

He also is on the Graduate Faculty, Department of Counseling, Educational Psychology, and Research at the University of Memphis. Professor Strauser's teaching and research interests include the assessment of individuals with disabilities and psychological factors that impact the career development and vocational behavior of such individuals. He is also interested in the impact of trauma symptoms on career development and the impact of the working alliance on rehabilitation outcomes, psychological wellbeing and career development. He has published over 50 peer-reviewed articles and is currently Editor-in-Chief of Rehabilitation Research, Policy and Education and editorial Board member of the Journal of Violence and Trauma Research, Dr. Strauser is the recipient of the United States Department of Education-Rehabilitation Services Administration Commissioners Award (2005), Deans Excellence Award- Excellence in Research and Scholarship (2004), and the American Rehabilitation Counseling Association Research Award (Second Place, 2004).

I bought this textbook because I needed to get up to speed on some neglected areas of vocational

rehabilitation in order to better serve adults on the high end of the autism spectrum. I supposed it would be good, it was much better than I had hoped. It is not just practical and useful, it is thorough and scholarly. The citations are very good, good enough that if I want to know more then I can use them to review the literature and find more about some troubling detail specific to my needs. The fact that it follows CORE accreditation standards makes it, in my opinion, more practical than otherwise. I have not used this textbook to teach a class--I am a working professional, not an educator. So as a seasoned vocational professional assisting those with disabilities to secure gainful employment I recommend this work highly and commend its author Professor Strauser for keeping it real, practical and scholarly. As an autism expert, I recommend it to those who need to know more about the vocational expertise of the vocational experts who specialize in serving those with disabilities --namely vocational rehabilitation counselors.
