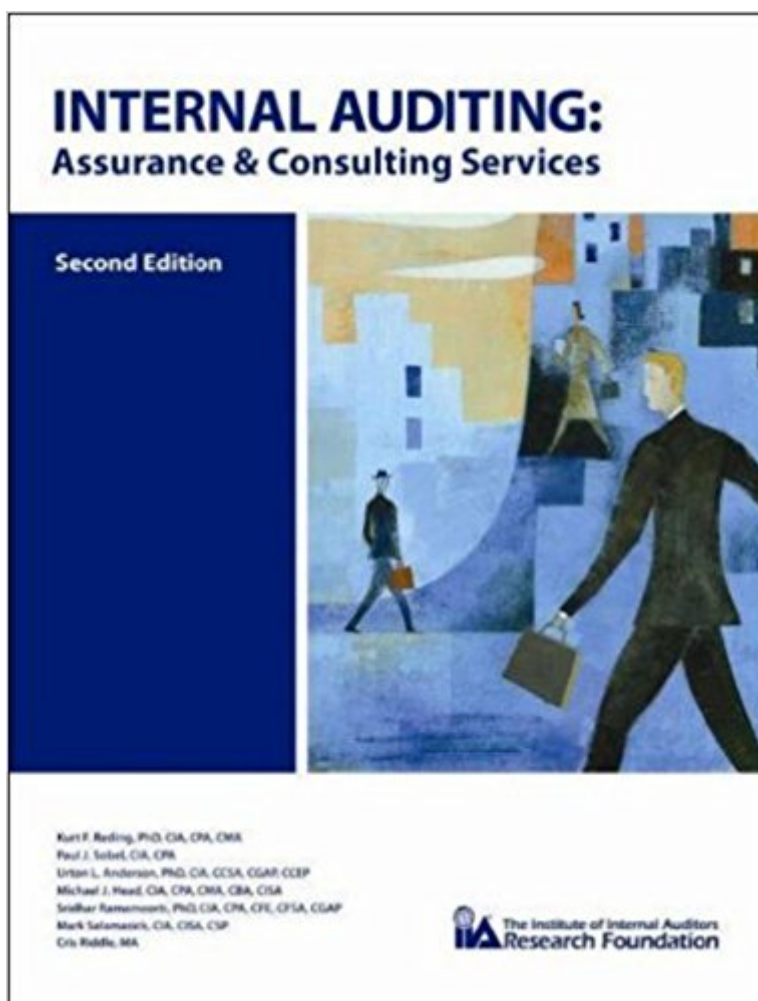

The text is clearly relatable to those who have done auditing before. To others, however, it feels abstract and unpractical. For example, when talking about working papers it never gives a single example of what a finished working paper actually looks like. The reader is left with an ideal description of working paper qualities, while the actual product remains illusory. The text is also biased in favor of SOX, despite conflicting academic research on the benefits of the regulation.

Not a good book. Very bland writing on the part of the author team (looks like a ton of people contributed to the book.) The info within it is accurate but it largely seemed like all the chapters basically said the same thing over and over again. "It is not the internal auditor's job to detect risk or conduct ERM; their job is to make sure all of the internal controls work, and to give assurance to top management that they work." This book will not teach you how to become a good auditor, nor will it teach you more than the very basics of the fine art of internal auditing.
